The undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the general corporation laws of the State of West Virginia, does hereby certify as follows SECTION ONE - NAME - The name of the corporation is Briar Run

SECTION TWO - <u>DURATION</u> - The corporation shall have perpetual succession by its corporate name

SECTION THREE - <u>PURPOSES</u> - To be and constitute the association to which reference is made in the Declaration of Covenants,

Conditions, Restrictions and Easements for Briar Run Estates, and all supplementary declarations applicable to all or any part of Briar Run Estates, Charles Town District, Jefferson County, West Virginia, and recorded in the Office of the Clerk of the County Commission of Jefferson County, West Virginia, as the same may be amended from time to time

To promote the health, safety, and welfare, and in furtherance of the interests of owners of the above described real estate in $B_{rightar}$ Run Estates

It is anticipated that this corporation shall be considered a "homeowners association," as the term is defined under 26 U S C Section 528 (c) (1), to take maximum advantage of the election to be a homeowners association under such statute

To carry on any lawful business whatsoever that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise or that it may deem appropriate, directly or

andirectly, to improve the interests of the corporation, and to do all things specified in the West Virginia Code and to have and exercise all powers conferred by the laws of the State of West Virginia on corporations formed under the laws pursuant to which and under which this corporation is formed as such laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons, firms, associations or corporations and in any part of the world

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in aid of the powers of this corporation and the powers and purposes stated in each clause shall, except where otherwise stated, be in no way limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to limit in any manner the aforesaid general powers but are in futherance of, and in addition to and not in limitation of, said general powers
